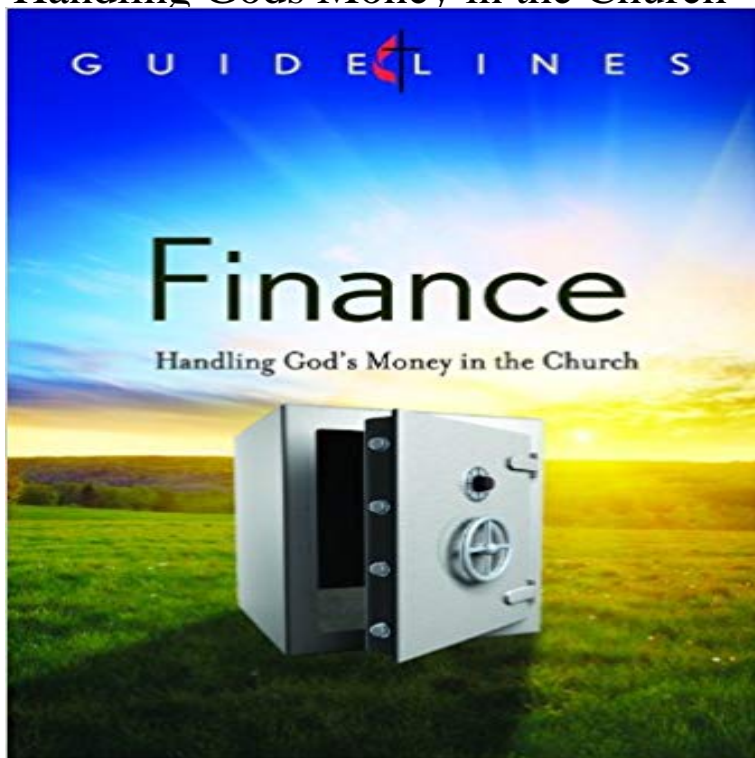


Guidelines for Leading Your Congregation 2013-2016 - Finance: Handling Gods Money in the Church
